PRODUCT OVERVIEW

The Opti Safe 1.7 Litre Sharps Container is a yellow medical waste sharps container with a special lid opening designed for used cannulas, scalpels, butterfly systems, tubes, pipettes, syringes, broken glass and longer-stemmed sharps. Constructed from polypropylene; minimum material thickness 1.7 mm and supplied as a high-visibility yellow medical waste container, it provides an identifiable, controlled disposal point that supports safe handling of contaminated sharps and clinical waste.



WHY THIS PRODUCT EXISTS

Sharps disposal points can present significant operational and compliance risks, including:

- Needle-stick injuries
- Tampering or unauthorised access to contaminated sharps
- Cross-contamination risks
- Incorrect disposal of sharp or contaminated clinical waste
- Compliance failures where sharps are not controlled at point of use

This container is designed to mitigate these risks by providing a purpose-built sharps disposal point matched to the application, waste type and required capacity.

The QSopt 1.7 provides controlled containment for sharps and contaminated clinical waste. It supports:

- Special lid aperture for longer and varied sharps
- Break-out protective flaps for variable aperture use
- Reduced spill risk if accidentally knocked over
- Clear identification of biohazard and medical waste disposal points
- Compatibility with IDC Medical QS Series sharps waste systems
